## Law and Order Ordinance

### Judgment Schedule

#### *Classification of Violations and Judgments*

- (A) The following civil judgments apply to each violation:
  - (1) Class C Violation civil judgment not to exceed \$250.
  - (2) Class B Violation civil judgment not to exceed \$2,000.
  - (3) Class A Violation civil judgment not to exceed \$5,000.
- (B) Any person who repeatedly commits a Violation will be subject to the following penalties:
  - (1) A person committing a Class C Violation three (3) times may be subject to a Class B civil judgment;
  - (2) A person committing a Class C Violation four (4) or more times may be subject to a Class A civil judgment;
  - (3) A person committing a Class B Violation three (3) or more times may be subject to a Class A civil judgment;
  - (4) A person committing a Class A Violation three (3) or more times may be subject exclusion.

Amount of financial loss is less than \$20 (Class C)..... \$250

Amount of financial loss is \$20 – \$249 (Class B) ..... \$2000

Amount of financial loss is more than \$250 (Class A) ..... \$5000

Section 4.02 Trespass (Class A or B)

Trespass (Class B)..... \$500

Previously excluded or debarred (Class B)..... \$2000

Committed in a private dwelling, a tribal building or  
while carrying a dangerous weapon (Class A)..... \$5000

Section 4.03Arson (Class A)..... \$5000

CHAPTER 8. TRAFFIC VIOLATIONS

Section 8.01 Unlawful Operation of Motor Vehicle ..... Class C Violation

- (1) Willful disregard for safety ..... \$250
- (1)a Driving in excess of 25 mph on paved road (unless otherwise posted)
  - Up to 10 mph over..... \$50
  - 11 to 20 mph over..... \$150
  - Over 20 mph over..... \$250
- (2) Driving in excess of 10 mph on unpaved road (unless otherwise posted)
  - Up to 10 mph over..... \$50
  - 11 to 20 mph over..... \$150
  - Over 20 mph over..... \$250
- (3) Driving in excess of any posted speed limit
  - Up to 10 mph over..... \$50
  - 11 to 20 mph over..... \$150
  - Over 20 mph over..... \$250
- (4) Disregarding any posted road or traffic sign..... \$100
- (5) No seatbelt..... \$50
- (6) No license or vehicle registration..... \$50
- (6)a Suspended license ..... \$100
- (7) No proof of insurance ..... \$50
- (8) Child not in child safety seat ..... \$100
- (9) Without factory installed, operational lighting or equipment ..... \$25
- (10) Operates motorcycle or ATV without helmet or spark arrester ..... \$50
- (11) Refuses to provide driver’s license or proof of insurance ..... \$250

Section 8.02 Unlawful Parking or Storage of Abandoned

Motor Vehicle ..... Class C Violation

- (A) Unlawful Parking is parking, stopping or leaving a motor vehicle within
  - (1) Area designated for emergency vehicle ..... \$100
  - (2) No parking area ..... \$100
  - (3) Tribal Elder parking ..... \$100
  - (4) 20 feet of fire hydrant ..... \$100
  - (5) Disabled parking area ..... \$100
  - (6) Tribal Council parking ..... \$100
  - (7) Area designated for emergency vehicle..... \$100
  - (8) Area designated for casino employee of the month ..... \$100
- (B) Storage of more than two nonoperational vehicles on  
Tribal or Private Property..... \$100
